

**OXFORD COUNTRY CLUB**  
**MEMBERSHIP APPLICATION AND AGREEMENT (2022)**  
(Revisions approved by the OCC Board of Trustees on (February 14, 2022)

**Section 1. Application**

- A. **General.** This membership Application and Agreement (“Application”) is submitted by the undersigned (“Applicant”) for the purpose of applying for Membership in The Oxford Country Club (“Club”). The Application for membership is subject to the *OCC Code of Regulations* and *Membership Rules & Regulations* of the Club.
- B. **Membership & Payment.** The Applicant applies for the following classification and category of membership (“Membership”) in the Club. These classifications and categories are described in the *Membership Rules and Regulations*. *Once accepted the applicant will be liable for twelve months of payments from the stated start date and is committing to at least a one-year membership. After twelve months from the stated start date the member will be liable for dues on a month-to-month basis, and the member shall continue to follow the “OCC Code of Regulations (By Laws).”* After twelve months, should a member resign or leave the club for any reason, the member shall do so under the “*OCC Code of Regulations (By Laws)*” and be responsible for the balance of dues and applicable fees incurred while a member at said “Club”. If a member resigns, all payments theretofore made shall inure to the benefit of the Club, and shall not be returned to the applicant or member, and he/she shall have no claim on the property rights or interest in the Oxford Country Club, Inc.

- E. **Membership Rules and Regulations.** The Applicant has received and read the *OCC Code of Regulations (By Laws)* and the *Member Handbook including Membership Rules and Regulations*. The Applicant fully agrees to be bound by the terms and conditions thereof as changed from time to time. All such rules and regulations are subject to amendment, modification, or supplement at the discretion of the Board.
- F. **No Ownership or Right to Participate in Management.** In all membership categories except Full Club, the Applicant acknowledges and agrees that Membership in the Club does not include: (i) any ownership or other proprietary interest in the Club or any of its assets, (ii) any right to receive or participate in the earnings of the Club, or (iii) any voting rights or any right to participate in the management or operation of the Club. Full Club Memberships do have ownership and voting rights as defined by the “*OCC Code of Regulations*” and “*Membership Rules and Regulations*.”
- G. **Authorization to Contact References.** The Applicant authorizes the Club to contact and obtain information from the Applicant’s personal references identified in Section 3. The Applicant also authorizes the club to inquire of the Applicant’s bank and creditors concerning the Applicant’s worthiness, promptness of payment, or other data to review the Applicant’s credit rating and to conduct any other check of the Applicant’s personal history. The Club shall keep any information obtained confidential with respect to persons not authorized by the Club to evaluate the Applicant’s application.
- H. **No Convictions.** The Applicant represents and warrants to the Club that the Applicant has never been convicted of, nor entered a plea of guilty or nolo contendere with respect to, (i) a felony under applicable federal or state law or (ii) a lesser crime than a felony that involved an act of moral turpitude or dishonesty by the Applicant.

**Indemnification and Assumption of Risk.** By executing this Application, the Applicant, upon becoming a Club Member, agrees to indemnify, defend and hold the Club (and its owners, officers, employees and other agents) harmless from and against any and all liabilities, costs (including reasonable attorneys’ fees), claims, demands or damages incident to or arising out of the acts or omissions of the Applicant, his or her Family members or Guests, arising out of or relating to the use or occupancy of the Club Facilities. In addition, Applicant agrees to hold the Club (and its owners, officers, employees and other agents) harmless from any and all damage to the Applicant’s person or property, and the person or property of the Applicant’s Family and Guests arising out of or relating to the use or occupancy of the Club Facilities.

## Section 2. Agreement

The execution of this Application constitutes an acceptance by the Applicant of the terms and conditions of Membership in the Club in accordance with the provisions of this Application.

The submission of this Application to the Club does not constitute acceptance of the Applicant as a Club Member until receiving written notice from the Club of acceptance and the payment in full of the initiation fee if applicable. The applicable payment is submitted with this Application. It is understood that, if not accepted, this payment will be fully refunded.
